Mark has a degree in Philosophy from Northwestern University and in 2016 was named to Forbes' 30 under 30 in Energy. He was a policy volunteer for the Biden Presidential Campaign on the Subcommittee on Environmental Justice, and is working on a book on climate change solutions with Justin Gillis and Hal Harvey.
